

Purpose

In accordance with the Club Constitution this Policy outlines the criteria for the awarding of annual performance and achievement awards. These awards earned over the current season are, where possible, to be presented at the annual presentation night / Junior awards night as appropriate.

Introduction

Awards may vary from time to time in accordance with the current environment or as determined by the committee.

Perpetual Awards and Criteria

The following are the current awards covered by this policy.

- Ted Mawdsley award for the Best Club Person. Nominations are to be made to the Secretary based on a 3-2-1 preference. The committee will then determine by – Best Club Person
- Ian Chisholm Award for Turf Player of the Year. The award is performance based in accordance with the points earned. Refer **Points Table 1**
- Rod Allan Award for best 2nd XI player of the year. This award is determined by obtaining votes based on 3, 2, 1 from the opposition team in each of the home and away rounds.

Ray Henry Award for Synthetic Player of the year. The award is performance based in accordance with the points earned. Refer **Points Table 1**

- Michael Cashen Memorial Award for 1st XI Best and Fairest. This award is determined by obtaining votes on the basis of 3, 2, 1 from the opposition team in each of the home and away rounds.
- W.J Henry Award for most Promising Junior player. This award is voted/recommended by the Coach and ratified by the committee
- A.Eastick Award for Junior Club Champion. This applies to the highest age group and grade of junior Cricket affiliated in the current season. The award is performance based in accordance with the points earned. Refer **Points Table 1**
- Fraser Hopgood Memorial Award (Coaches Award). This award is voted/recommended by the Coach and ratified by the committee
- Ashley Henry T20 Award (T20 player of the season) The award is performance based in accordance with the points earned. Refer **Points Table 1**

Batting and Bowling Awards

The following criteria is used to determine the winners for club Batting and Bowling awards. These statistics are based on both the home and away season and Finals series matches.

This applies to both Senior and Junior players.

Batting:

- The number of innings is based on DDCA eligibility less one.
- The number of runs is based on the DDCA eligibility for each grade less 10%. There is no Criteria for under 10
- If no one fits the criteria, then this can be reduced by 10 runs until someone meets the criteria. If no one has met the criteria after a 30% reduction in runs, there is no batting average awarded
- If batsman not dismissed, the average will be calculated as if dismissed once

Bowling:

- Based on the DDCA eligibility for each grade less 10%. There is not a Criteria for under 10.
- If no one fits the criteria, then this can be reduced by 5 overs until someone meets the criteria. If no one has met the criteria after a 30% reduction in overs, there is no bowling average awarded.
- For seniors the number of wickets is DDCA criteria less two. If no one meets this then reduce by another two but no less than 16 wickets

Perpetual Awards

- Ian Chisholm Award for Turf player of the year
- Ray Henry Award for Synthetic player of the year
- A Eastick Award for Junior Club Champion
- Ash Henry Award – T20 Player of the season

Points for these Awards are calculated according to the following table.
